Charles Stull made a motion to hire Jodi Greizer as part time patrolman with a salary of 90% rate while on probation, 95% for 1 year followed by full rate. Kris Kulick seconded. Motion carried.

Charles Stull made a motion to advertise for the PMRS ordinance. Jeremy Smail seconded. Motion carried.

Charles Stull made a motion to approve the resolution from PMRS. Jeremy Smail seconded. Motion carried.

Chris Fabec, Chief, read the police report this month. Kris Kulick made a motion to approve the report. Jeremy Smail seconded. Motion carried.

Sharon Long, Zoning Officer, read the zoning report. Charles Stull made a motion to approve the report. Kevin Miller seconded. Motion carried.

There was no dog report this month.

Ted Long, Foreman, was read his road report for the month. Kris Kulick made a motion to approve the report. Jeremy Smail seconded. Motion carried.
