Roll call was as follows: Linda Alworth - absent; Jeremy Smail - present; Charles Stull - present; Kris Kulick - present; Kevin Miller - present; Sharon Long - present; Tim Miller - present, SARPD - absent; Ted Long - present.

VISITORS WRITTEN REQUESTS:

Paul St. John of 106 Silicon Drive spoke about parking in the street. He states there are cars from a neighbor that constantly park there. Tim Miller, Solicitor, will look into parking or no parking regulations on township roads.

Sharon Long, Secretary Treasurer, presented the minutes from the previous meeting. Jeremy Smail made a motion to approve the minutes. Kevin Miller seconded. Motion carried.

A brief discussion was held regarding the house on Raymond Road that sits empty. The estimate for removal was turned over to the county for the demo but no estimate was given for asbestos removal. Jeremy Smail made a motion to leave this discussion on the table. Kevin Miller seconded. Motion carried.

Charles Stull made a motion to leave on the table the receiving of the property in Georgetown and to have Tim reach out to the owner again. Jeremy Smail seconded. Motion carried.

Jeremy Smail made a motion to switch the sewage enforcement from Armstrong County Sewage Enforcement Agency to Spurgeon Schilling with Tim Miller, Solicitor, coming up with a better defined contract between the two parties. Charles Stull seconded. Motion carried.

Kris Kulick made a motion approve the Tracy LERTA application. Kevin Miller seconded. Motion carried.

Charles Stull made a motion to amend the PMRS pension plan, and approve the resolution, waiving the 5% contribution. Jeremy Smail seconded. Motion carried.

Sharon Long, Zoning Officer, read the zoning report. Jeremy Smail made a motion to approve the report. Kris Kulick seconded. Motion carried.

Ted Long, Foreman, was read his road report for the month. Kevin Miller made a motion to approve the report. Kris Kulick seconded. Motion carried.
