VISITORS WRITTEN REQUESTS:

Fred Stubble 836 Schenley Road spoke about the nuisance ordinance he said that there are several properties within the township that are looking pretty messy.

Pete Pinto submitted his letter of resignation from the KVWPCA (Kiski Valley Water Pollution Control Authority) he will remain on the Gilpin Township Municipal Authority however. He wanted to give a recommendation of Bob Swarmer to fill his seat at KVWPCA. Pete Pinto gave a small summary of what is currently going on with the KVWPCA. Susan Brown asked Sharon Long, Secretary Treasurer, if the budget could withstand these increases and Sharon Long stated
